A Note from the Department Chair, Dr. Stefan Niewiesk

Dear Alumni and Friends of the Department of Veterinary Biosciences,

I would like to announce a change in the leadership of the Department of Veterinary Biosciences. I have decided to return to the faculty ranks and Dr. Prosper Boyaka will serve as Interim Chair beginning July 1, 2020. Dr. Boyaka is a Professor of Immunology and joined the department in 2006. He is leading a very successful research group and is eminently suited to guide the department as its chair.

I would like to thank our faculty and college leadership for the opportunity to serve as chair of VBS. Over the last 3½ years, the department has been on an upward trajectory. We have recruited two clinical faculty, thus extending and improving our pathology program, as well as four tenure-track faculty to further our research

enterprise in infectious diseases and cancer. Understandably, the current pandemic has hindered our continued recruitment efforts and programmatic development; however, I take heart from the way our faculty have responded. Like many of you, The Ohio State University has had to navigate unprecedented waters during the COVID-19 pandemic. With a large swath of employees and faculty required to telework for the safety of their community and their families, the Department of Veterinary Biosciences has found

Dr. Jerry Masty received the 2019 Association of American Veterinary Medicine Colleges (AAVMC) Distinguished Veterinary Teacher Award, which designates him as the outstanding veterinary medical educator of the year in the United States. 
Pathology Retreat in December
